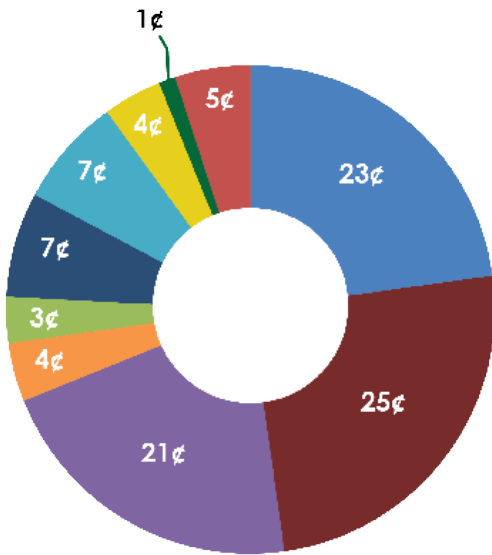


Your final 2022 tax bill is enclosed. This bill is payable in two instalments, the first on July 27, 2022 and the second on Sept. 27, 2022.

The Town of Georgina issues and collects your property tax billing, including those levied by the Town of Georgina, Region of York and Ministry of Education. The calculation of your property tax amount is determined by multiplying the current value assessment of your property by the applicable tax rate. We have provided within this brochure all 2022 tax rates for the Town of Georgina, Region of York and Ministry of Education.

Tax and Water Portal



Did you know?

The Town has an online tax and water portal. It allows residents to receive and view their tax and water bills electronically. Residents can set up an account and gain access to their bills using the PIN number and account number that is located on their bills. 2022 Town of Georgina Budget Highlights

Georgina Town Council approved its 2022 tax rates on May 18, 2022. When combined with the regional and education tax increases, the overall impact results in an increase of 1.44% or \$59.20 for the average home with a current value assessment of \$402,995. The 2022 Budget has \$92.8 million in expenditures, which includes \$78.8 million in operating expenses and \$14 million in capital expenditures (excluding carry forward capital and MURC cash flow estimates). Funding sources for the tax levy supported expenditures are derived in part by revenues generated by user fees, permits and licences, federal and provincial grants, Canada Community Building Fund and development charges. This year, Georgina will receive \$1.4 million in Canada Community Building Fund Funding.



Property tax payment options:

Payments can be made by telephone/internet banking or at any bank. Payment by cash, cheque or debit can be made in person at the Civic Centre. There is a drop box at the front door of the Civic Centre for those wishing to drop off a cheque. For more information, visit georgina.ca/taxes.

Monthly pre-authorized payment plan information:

The Town of Georgina offers three pre-authorized payment plans

- 12-month plan with a withdrawal date on the first day of the month
- 12-month plan with a withdrawal date on the 15th day of the month
- Instalment plan with four withdrawals per year

Highlights of the 2022 operating budget include:

- \$2.3 million investment in roads selective resurfacing, maintenance and rehabilitation
- \$1.1 million for the Emerald Ash Borer (EAB) tree removal program
- \$1 million for the Pefferlaw Dam
- \$1.4 million for recreational amenities in Pefferlaw
- \$850,000 for a rescue pumper apparatus
- \$756,000 towards the Building Condition Assessment (BCA) program, and facilities repairs and remediation program
- \$600,000 for the culvert and ditch design and rehabilitation program
- \$330,500 for community organizations including Georgina Centre for the Arts and Culture, Georgina Chamber of Commerce, Georgina Farmers' Market, GTTI, the Military Museum and Routes Transportation
